Beginning April 2023 Photo ID Rules Change for Voting

House Bill 458 passed in December 2022 that made changes that impact what information is needed to vote:

Absentee "In-Person" or EARLY VOTE

Absentee by Mail

On Election Day In-Person.



What is NOT Changing?

VOTER REGISTRATION VOTING ABSENTEE BY MAIL

YOU CAN REGISTER TO VOTE AND VOTE BY MAIL USING THE NUMBER ON YOUR STATE ISSUED ID/DRIVER'S LICENSE on the application.

<u>OR</u>

THE LAST 4 DIGITS OF YOUR SOCIAL SECURITY (SSN) NUMBER



A PHOTO ID NOW REQUIRED

To Vote EARLY VOTE "In-Person" at the county board of election or early vote center

and

To Vote "In-Person" on Election Day at your polling location.



Required Photo ID for Voting in Ohio after April 7, 2023

ALLOWED

Valid Driver's license (unexpired)
Valid State Issued ID (unexpired)
Valid Passport (unexpired)

NOT ALLOWED

- Expired Driver's License or State ID
- Expired Passport
- Utility Bill, Govt. Paycheck, Bank Statement, Government Document with Current Address

IF YOU VOTE 'IN PERSON' WITHOUT A PHOTO ID

YOU MUST CAST A PROVISIONAL BALLOT AND

YOU WILL HAVE UNTIL 4 DAYS AFTER ELECTION DAY TO PROVIDE YOUR PHOTO ID TO THE BOARD OF ELECTION OR YOUR VOTE WILL **NOT BE COUNTED**

OR

YOU WILL HAVE 4 DAYS AFTER ELECTION DAY TO PROVIDE AN AFFIDAVIT OF RELIGIOUS OBJECTION TO PHOTO IDENTIFICATION OR YOUR VOTE WILL **NOT BE COUNTED**



Ohio will issue a State Issued ID card at no cost if - -

- You are at least 17 years of age
- You currently <u>do not have a driver's license or have a suspended</u> <u>driver's license</u>
- You apply for state ID at a County Bureau of Motor Vehicles (BMV) with required documents
- Your name changes for example, because of marriage or divorce, between replacement years and you need your ID card re-issued



^{*} Duplicate or reprints for lost or damaged cards will REQUIRE PAYMENT

Ohio will **NOT** issue an ID card at no cost if

You have a current/valid Ohio Driver's license.

You need a duplicate or reprinted ID card for lost or damaged cards.



Required Documents to Get an Ohio Photo ID

You need to present documentation of these 6 elements in order to obtain your Driver's License or State ID from the Bureau of Motor Vehicles

- 1. Full Legal Name
- 2. Date of Birth
- 3. Legal Presence In U.S.
- 4. Document with Social Security Number
- 5. Ohio Street Address
- 6. Proof of Name Change, if applicable

- Bank Statement
- Auto Title

- W2 *current or previous year
- 1099 Form with full SSN

(6) Name Change, if applicable

Original or certified copy of marriage certificate or license or certified copy of divorce decree/dissolution or annulment of marriage or certified copy of court ordered name change.



What we can be doing now.

- 1. Inform Ohioans that voter ID rules have changed for "inperson" voting.
- 2. Encourage Ohioans to get the **REQUIRED** documents together in order to get a valid photo ID.
- 3. Share info with those eligible how to get a free state ID
- Share info that you can still vote by mail using last 4 of SSN or DL/ID number
- 5. Reinforce voters will only have four (4) Days after Election Day to provide a valid photo ID or affidavit if they vote provisionally or their vote will not be counted.

When 40% can overrule 60%- Ohio on a dangerous path

- Some members in the Ohio Legislature attempting to weaken the strength of the will of the majority of Ohio Voters by changing the Ohio Constitution.
- HJR1 and SJR2 2 companion legislation that would place language on the state ballot in August to change the constitution which if passed would require at least 60% support for constitutional changes.

Why it Matters.

- 1) The General Assembly is attempting to AMEND The CONSTITUTION to allow a MINORITY TO **ALWAYS DEFEAT a SIMPLE MAJORITY OF VOTERS**
- 2) The General Assembly is intentionally placing this issue on an August special election which sually has low voter turnout to assure easy passage.
- 3) It is not EASY to get 51% support even for a great beneficial idea. Raising the threshold to 60% weakens the power of the voters' voice by giving greater weight to a **no** vote than a **yes** vote.

The hypocrisy of it all

- In December of 2022, the General Assembly voted to eliminate August special elections to only school districts that were in fiscal emergency and put in LAW that the local subdivision that put an issue on an August ballot had to pay for it.
- August is the election where as few as 10% of eligible voters participate, but some want to put this major change, which has been in the Constitution since 1912, on the ballot in the lowest turn-out election.
- Supporters of this change offer weak and contradictory rationale to what they argued in December.

HJR1: A power grab to kill ballot initiatives

HJR1 would make it almost impossible to pass a ballot initiative by raising the required pass percentage from 50 to 60% and adding other obstacles.

Push back:

 Inoculate the public with our ideas before they hear from HJR1 proponents.
