

WHAT IS OURS?

The mission of the Ohio Urban Resources System (OURS) is to empower Ohio's urban Community Action Agencies for maximum impact. We envision the Ohio Urban Resources System as a leading entity strengthening the social and economic security of families and their communities.

Ohio Urban Resources System serves as a catalyst for capacity building and advocacy within urban Community Action Agencies (CAAs) in the State of Ohio. We do this in the following ways:

- * Promoting smart solutions and promising practices.
- * Providing direct leadership development, including mentoring.
- Providing direct technical assistance to CAAs in the areas of consumer input and involvement, community engagement, community assessment, organizational leadership, board governance, strategic planning, human resources management, financial operations and oversight and data and analysis.
- Directly advocating and promoting advocacy of the interests of low and moderate income residents in urban and metropolitan areas of Ohio.

In the early 1980s, Community Action Agencies in Akron, Ashtabula, Canton, Cincinnati, Cleveland, Columbus, Dayton, Lima, Lorain, Toledo, Youngstown and Zanesville realized that due to Ohio's unique demographics (more large urban centers than any other state in the country) networking to address issues collectively would be necessary. Ohio Urban Resources System (OURS) was incorporated in 1985 to represent the needs and interests of Ohio urban poor families and residents.

Today, OURS agencies represent 56 percent of the state's total population and 62 percent of those households are living at or below the Federal Poverty Level. We seek to reduce the number of households living in poverty so that no family experiences food insecurity or housing challenges and all are able earn a livable wage.

OURS mission is to is to empower Ohio's urban Community Action Agencies for maximum impact. We envision the Ohio Urban Resources System as a leading entity strengthening the social and economic security of families and their communities.



Everyone holds bias and it is more likely to be called out when it manifests within our leaders. Calling for greater diversity, equity, and inclusion can only be effective if leaders are "walking the walk" themselves. This workshop will provide foundational knowledge of social challenges and best practices to achieve cultural awareness.





Simone Crawley is the Founder and Chief Executive Officer of Crawley Cultural, a consulting firm guiding both businesses and individuals as they address their implicit bias and implement diversity, equity, inclusion, antiracism and cultural competence. Clients represent the finance, health, education, public safety, and legal fields.

She most recently served as the Executive Director for the Multiethnic Advocates for Cultural Competence (MACC), an Ohio non-profit managing cultural competence in health and behavioral health. Her career started in public policy with a seven-year tenure in the Ohio Legislature, during which she advocated for the Black electorate and aided campaigns as President of the Ohio Young Black Democrats. In an effort to expand the knowledge of her clients, Simone teaches the a concept she coined known as Cultural CASH

(cultural competence, cultural awareness, cultural sensitivity, cultural humility). She is a certified instructor of the Adult and Youth Mental Health First Aid curricula and holds a degree in Political Science from The Ohio State University.

How to Lead with Authenticity with Dr. Patrese Mason


